

HYDROGRAPHIC SURVEYING COURSE

STET Maritime (Singapore) in collaboration with the Maritime & Port Authority of Singapore (MPA); is proud to announce our second intake of the “**Hydrographic Surveying Course**”.

We are pleased to inform you that our second intake of the course, commencing on 26th September 2011 is now open for registration. Closing date for application is on **19th August 2011**.

Our Hydrographic Surveying Course has been included as a pre-approved certifiable program supported under the MPA Maritime Cluster Fund's (MCF) Training@MaritimeSingapore scheme in 2011. The MCF support would be applicable to participants enrolling into the program in 2011.

To be eligible for the training grant, applicants must meet the following requirements:

- Singaporeans and Singapore PRs sponsored in full by a maritime business registered or incorporated in Singapore.
- Singaporeans and Singapore PRs who are self-sponsored may apply, provided that they have a letter of support or recommendation from employer; and
- Applicants must successfully complete the program and be awarded with the certification.

The training grant is pegged at 60% off the course fee (excl. of GST) per pax for company sponsored participant and \$5,000 per pax for self-sponsored participants (with letter of recommendation from company). Training grants will be given on a reimbursement basis after successful completion of the course.

Applicants must submit their applications to the MCF Secretariat for the funding 30 days before the commencement of course. Approval is subject to the fulfillment of all eligibility criteria. MPA reserves the right to reject any application in the event of failure from participants/businesses to comply with or observe any of the eligibility criteria.

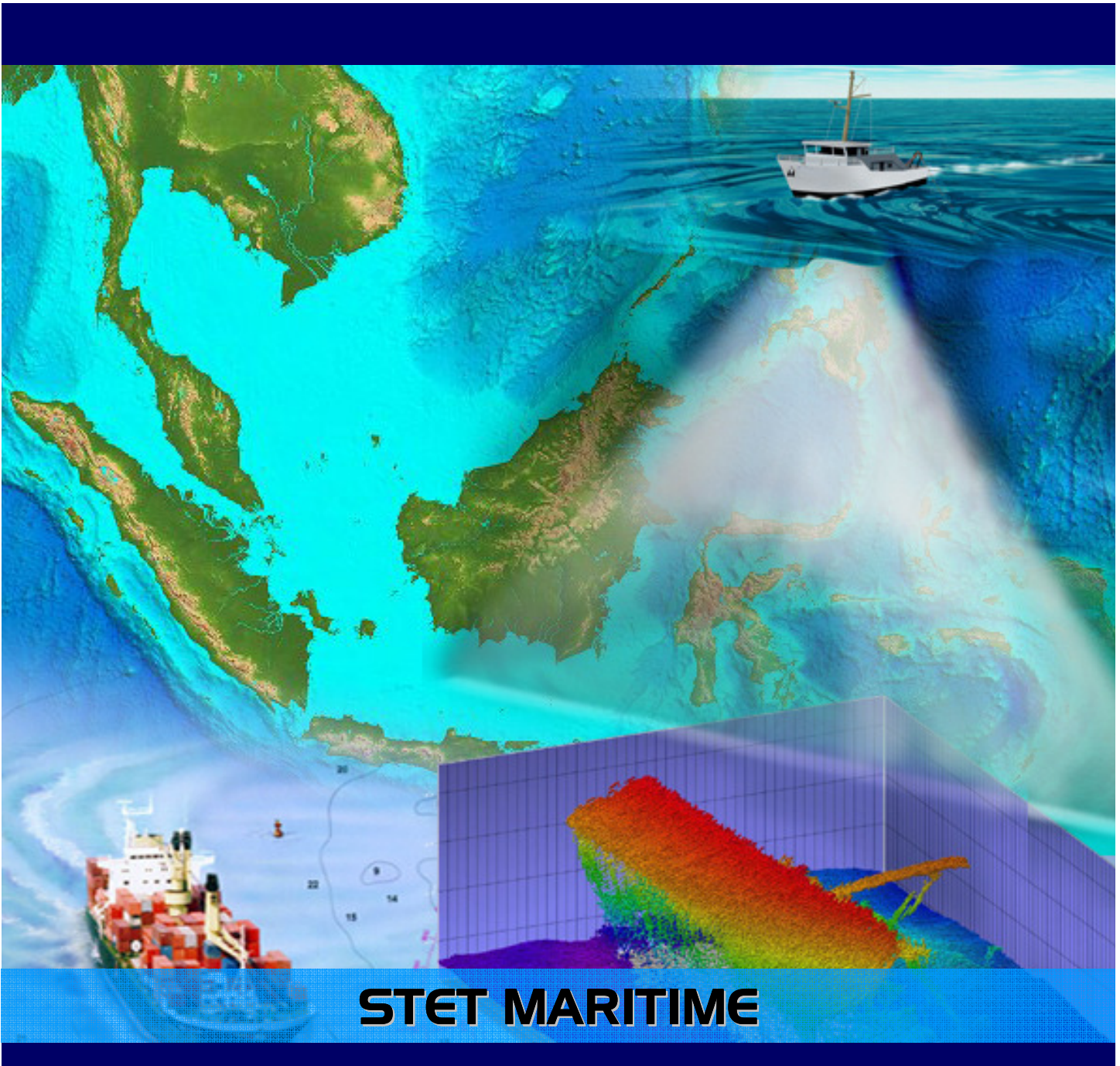

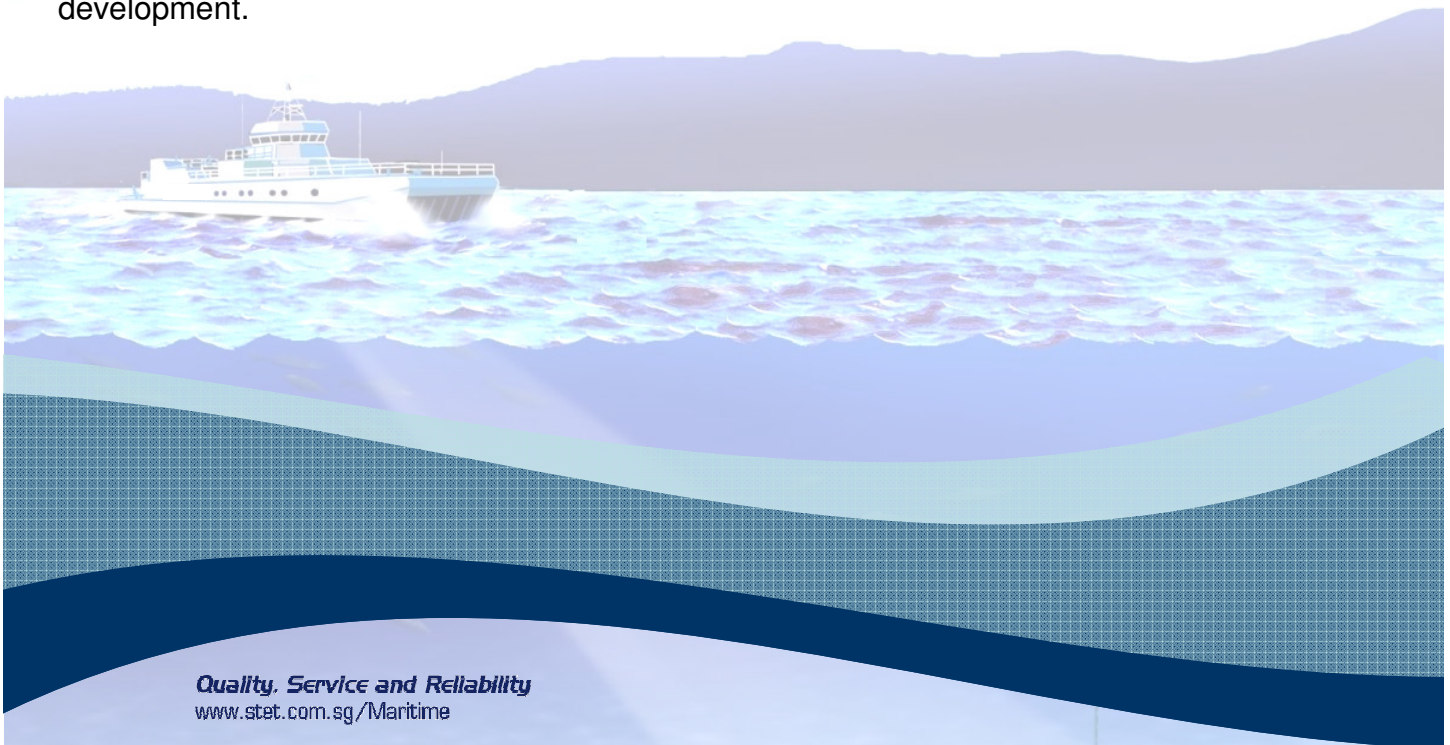

ABOUT THE COURSE

ENTRY REQUIREMENTS

All admissions are subjected to approval and selection of STET Maritime Pte Ltd.

- Completed 10 +2 years education (or equivalent)
- Applicants should preferably be from marine background with knowledge about basic navigation, seamanship and RoR.
- Basic understanding of Calculus, Trigonometry, Co-ordinate geometry, Algebra, Plane geometry, Statistics and Probability etc (Basic Maths).
- Basic understanding of concepts of Physics, viz, Mechanics, Electromagnetic waves, Optical principles, Electricity, Electronic systems etc (Basic Physics).
- Working knowledge of computers, windows operating system, Internet, concepts of database and information systems.
- Medically fit.
- All applicants are required to attend / complete STCW95 Basic Safety Training (BST) course before commencement of the course.

COURSE STRUCTURE

Phase I: 15 Weeks comprising theory & practical lessons.

Phase II: 2 years on the job training sponsored by a Company.

We provide a modular conduct of the program.

Applicants who have not completed the STCW95 Basic Safety Training (BST) course are required to attend additional 5-day training before commencement of the course.
